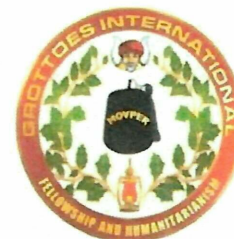

**ATTENTION:** Grand Line Officers, Past Grand Monarchs, Monarchs, Chief Justices, Secretaries and Supreme Council District Deputies

**EDICT**

It is important that the current Monarch and next year's probable Monarch - Elect (current Chief Justice) appoint Prophets to **four (4)** very important chairs as soon as possible. The appointments will be for 12 months beginning January 2, 2026. If the Prophet appointed last year has done a good job, please consider reappointing him to the same chair.

1. The Membership Chairman will supervise, encourage and promote the Grand Monarch's programs.
2. The Suspension Chairman will be responsible to see that someone from your Grotto, personally contact all members threatened with suspension, prior to suspending the Prophet.
3. The Doctor of Smiles will act as liaison between the families of children requiring dental care and the Humanitarian Foundation's Dentistry for the Special Needs Children Program and act as coordinator of the program at the local and/or state level.
4. The Enchanted Lantern Chairman will be responsible for sending all Enchanted Lantern request to the Supreme Council Office and maintaining the Enchanted Lantern records for their Grotto.

Please contact each Prophet and obtain his approval prior to affixing his name to the enclosed report form. The Supreme Council Office needs this information as soon as you can provide it, but no later than January 2, 2026.

**All forms that are to be filled out will be sent to your Grotto's Secretary. Please be sure to inform him of your appointments so that he can send the report in on time.**

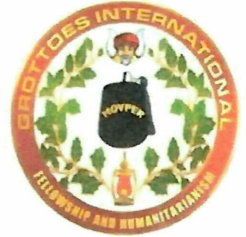

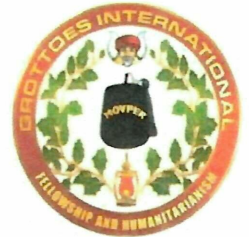

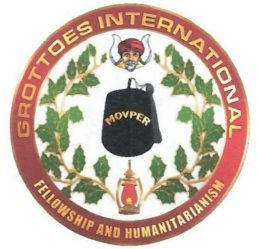

**EDICT**

Authority is hereby granted to all Grottoes in the Realm to reinstate all former members who have been suspended for non-payment of dues to active status upon payment by the former member of current dues in the Grotto from which suspended.

In addition to the current annual dues of his Grotto, a reinstated Prophet must also pay to the Supreme Council the following fee:

Reinstatement Fee of \$15.00 must be paid for the membership year of May 1, 2025  
To April 30, 2026.

Any member for a period of more than twelve (12) months will be credited toward the VIP Program upon reinstatement.

**Please note: The foregoing does not exempt any Grotto from the provisions of Chapter XXXII paragraph 32.16 of the Supreme Council Code when reinstating a former member.**
